- 1. The mission of the Austin Energy Department is to deliver clean, affordable reliable energy and excellent customer service. During your term, what will be the most important challenge for the city in regard to Austin Energy?**

To do just that. It's a tremendous challenge to deliver clean, affordable reliable energy and excellent customer service to the citizens of Austin.

- 2. From a citywide and district perspective, briefly describe your vision for managing and improving Austin Energy?**

I would continue the work that current Council has already done. Austin has been cited for being a leader in implementing building energy codes, adopting building energy disclosure policies, and for having a significant building performance workforce infrastructure. Beyond buildings, Austin Energy has also been a leader on district energy and combined heat and power (CHP) and is a leading municipal utility on efficiency programs. Austin is also notable as the city furthest ahead in our state on energy efficiency policy and implementation. Austin also scores much higher than Texas as a whole on equivalent metrics. And if elected, I would support an increase in Austin Energy's renewable 2020 goal and would look at auditing Austin Energy.

I think climate change is real and is becoming a problem that we need to address.
